Dear Member of AIPPI-US:

This is a mid-year report on activities and opportunities for participation in the International Association for the Protection of Intellectual Property (AIPPI) including the U.S. National Group (“AIPPI-US” or “U.S. Group”). As you will recall, membership in AIPPI is through membership in a national group, e.g., the U.S. Group.

AIPPI is the world's leading non-government organization for research into and formulation of normative policy for the laws of various countries relating to the protection of intellectual property. With 9,000 members organized into national groups, AIPPI unites practitioners, academics and owners of intellectual property.

AIPPI Mar. 6, 2011 Reception at USPTO Patent Harmonization Initiative

The U.S. Group of AIPPI sponsored the opening reception for the USPTO's “Asia-Pacific Patent Cooperation in the 21st Century” Conference, held in Washington, D.C., March 6-8, 2011, for discussion of patent law harmonization initiatives through the Asia-Pacific Economic Cooperation (APEC) Organization. We had great representation from the U.S. Group, the Bureau and other national groups in attendance at the event, which provided us with the opportunity to meet and talk with more than 50 IP leaders from more than 23 different countries, including USPTO Director **David Kappos** and Deputy Director **Teresa Rea**. US Group Reports for Hyderabad ExCo Meeting

The U.S. Group has submitted reports for the four working questions to be considered at the AIPPI-Hyderabad ExCo Meeting. Typically 30 or more of the leading national groups submit reports on each of the questions, which will be discussed in detail in working committee meetings in Hyderabad. Proposed resolutions from the committees are debated in the ExCo Meeting, leading to final resolutions of the international Association and/or further action steps including communication with the World Intellectual Property Organization (WIPO) and regional (EPO) and national patent offices. These resolutions help to shape international intellectual property treaties and laws as well as the laws of various regions and countries.

U.S. Committee on Amicus Curiae Briefs

As you may recall, last year, the U.S. Group took the lead in preparing and filing an amicus curiae brief with the imprimatur of AIPPI in the *Bilski* case in the U.S. Supreme Court. Most recently, the Amicus Committee, chaired by **Peter Schechter**, has been working with the U.S. ExCo and the international Bureau in considering a possible amicus brief in *Mayo v. Prometheus* (U.S. Supreme Court) (possible exceptions to patent protection for certain medical lab tests ordered by physicians).
